

OFFICIAL CALL
Mass Meeting
of Henrico County Republican Committee
of the Republican Party of Virginia

As Chairman of the Henrico County Republican Committee of the Republican Party, and pursuant to the Plan of Organization and as recommended and directed by the Committee, I, Thomas M. Branin, do hereby issue this call for a Mass Meeting to be held at Henrico County Government Center, Board of Supervisors Room, 4301 East Parham Road, Henrico, Virginia 23228 starting at 7:00 PM local time on Monday, March 24, 2014 for the following purposes:

1. Electing a Chairman and members of the Henrico County Republican Committee;
2. Electing up to 1,705 delegates and an equal number of Alternates to the Seventh Congressional District Republican Convention, to be held on Saturday, May 10, 2014 in the auditorium at Deep Run High School, 4801 Twin Hickory Road, Glen Allen, Virginia 23059, Henrico County, beginning at 10:00 AM with registration from 9:00 to 10:30 AM;
3. Electing up to 330 delegates and an equal number of Alternates to the Third Congressional District Republican Convention, to be held on Saturday, May 3, 2014 at the Governor Dinwiddie Hotel & Suites, 506 Dinwiddie Street, Portsmouth, Virginia 23704 beginning at 11:00 AM with registration from 9:00 AM to 10:45 AM.
4. Electing up to 2,195 Delegates and an equal number of Alternates to the State Convention of the Republican Party, to be held on June 7, 2014 at the Roanoke Civic Center, 710 Williamson Road, Roanoke, Virginia 24016 starting at 10:00 AM;

and for the transaction of such other business as may properly come before the mass meeting. The purpose of the District Conventions is to elect District Chairmen. The purposes of the State Convention are to nominate a Republican candidate for the United States Senate and any other business as may properly come before the convention. Henrico County is entitled to 341 Delegate Votes at the Seventh District Convention, 66 Delegate Votes at the Third District Convention and 439 Delegate Votes at the State Convention based on the Republican votes for president and governor at their last election.

Qualifications for Participation

All legal and qualified voters under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party, and who, if requested, express in open meeting, either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions, or primaries encompassing their respective election districts.

In addition to the foregoing, to be in accord with the principles of the Republican Party, unless otherwise stipulated by the appropriate Official Committee, a person otherwise qualified hereunder shall not have participated in Virginia in the nomination process of a party other than the Republican Party within the last five years.

A single exception to the above paragraph shall be approved for a voter that renounces affiliation with any other party in writing, and who expresses in writing that he/she is in accord with the principles of the Republican Party and intends, at the time of the writing, to support the nominees of the Republican Party in the future. Any voter that utilizes the foregoing exception, and thereafter participates in the nomination process of a party other than the Republican Party, shall not have this benefit of the exception thereafter.

Filing Requirements

Candidates for election as Chairman at said mass meeting shall file a written statement of intent with a \$500 non-refundable filing fee to Frances M. Boswell, Treasurer, by mail or in person at 5005 Hearthstone Court, Glen Allen, Virginia 23059 which must be received not later than 6:00 PM on Wednesday, February 5, 2014. The filing fee shall be by check for \$500.00 made payable to the Henrico County Republican Committee. Postmarks do not govern.

Candidates for election as a Delegate or Alternate to either of the District Conventions and/or State Convention or member of the Henrico Republican Committee shall file on an official 2014 pre-file form available on www.henricogop.com to Frances M. Boswell, Treasurer, by mail or in person at 5005 Hearthstone Court, Glen Allen, Virginia 23059, which must be received not later than 6:00 PM on Friday, March 21, 2014. Postmarks do not govern.

If only one candidate pre-files for election as Chairman, that person will be deemed elected.

Registration Fees

There will be a \$5.00 voluntary registration fee to participate in this mass meeting. There is a voluntary registration fee of \$35.00 for the State Convention and voluntary registration fees of \$25.00 for the 7th District Convention and \$5.00 for the 3rd District Convention. Voluntary fees are requested to be paid at the time of filing for election as a Delegate for each respective convention by checks made payable to the Henrico County Republican Committee.
